***Policies for Contract Court Time Reservations***

1. To apply for and maintain a CCT you MUST be a member of the PRITC (for the entire season, **no lapse**).
2. **All members must keep their membership active during the CCT times or guest fees WILL apply.**
3. CCT applications will be accepted beginning Friday, August 26, 2011.
4. Each Family Membership will be allowed two separate CCTs, each Single and/or Junior Membership will be allowed one CCT, until September 15, 2011 on a first come first serve basis.
5. Beginning September 15<sup>th</sup> all members may apply for additional CCTs on a first come first serve basis.
6. First 50% of total CCT is due with application to insure CCT reservation for the 2011-12 Season. Please Help us with our administration burden by collecting the entire amounts due from your players.
7. Final 50% of total CCT is **due no later than Friday, December 2, 2011** to pay final balance of CCT.
8. CCT is a contracted commitment (23, 24 or 25 weeks). Sorry, NO REFUNDS FOR EARLY CANCELLATIONS.
9. Each CCT is allowed **2 make-ups per season**. Cancellation of the court time must be made one week in advance to qualify for a make-up. Please call the front desk at 444-8363. We are always reasonable.
10. All players participating in a CCT must check in with the Front Desk before beginning play. Please be on time!
11. All guest and non-members participating in a CCT **must check in** with the front desk **and pay a \$7 per hour Guest Fee** before beginning play. **Members are responsible for making sure guests pay their fees.**
12. Each contract represents one court, one time. Separate courts and times must have CCT reservation forms completed along with the appropriate payment.
12. One can of Wilson US Open balls will be supplied for each CCT reservation, **to be returned** to front desk after play.
13. Please list all "regular" players in your group for our records. All players must sign Liability Waiver.
14. Additional times (greater than 2 hours) can be contracted. Please see Nathan for details, etc.
